

**ST. PETER SCHOOL  
TUITION POLICY AND FEES  
2018/2019 SCHOOL YEAR**

St. Peter School partners with FACTS Management Company to help us manage our tuition payment program. FACTS is used by most schools in the Archdiocese and over 5,000 schools nationally.

Families must complete a FACTS payment agreement in order for registration to be complete. Enrollment has to be done on line at <https://daytonxii.org/facts-payments-and-grants>. Look for the FACTS Logo. Customer/family id and amount due will be filled in by the tuition office. If a family already has a FACTS account, you may use that login information.

Some of the greatest benefits of using FACTS are convenience and security. Along with multiple payment plan options, your payments are processed securely through a bank to bank transaction. In addition, you are able to check your personal account or make payments online from the convenience of your home or office anytime.

You may choose a payment plan that works for you: Pay your balance in full (no enrollment fee), quarterly, or monthly. When paying in installments, you have the flexibility to choose either the 5<sup>th</sup> or the 20<sup>th</sup> of each month as your payment date. Your automatic payment can be made from a checking or savings account, MasterCard, Discover, or American Express. **A 2.85% convenience fee will be assessed for each credit card payment.** Your FACTS account will be debited the enrollment fee when an applicable plan is set up. The following are three different plans you can choose from for your tuition payment enrollment.

**PARISHIONER AND NON-PARISHIONER TUITION RATE:**

St. Peter Parish supports the school by providing funding from the weekly offerings to keep the tuition rate at a lowered amount. To receive the parish member rate for tuition, you must be a registered, supporting member of the parish. **If you are not an active member, you will receive the non-parishioner tuition rate.** A registered, supporting member of the parish is defined as an active parishioner registered with the parish who attends Mass and supports the parish through time, talents, and financial support (see financial obligation). This will be reviewed January 1 and adjustments will be made to your account if necessary.

**PARISH TUITION ASSISTANCE:**

A limited financial assistance fund is provided through the generosity of St. Peter Parish. One of the primary functions of a parish school is to provide, within reason, a Catholic based education for the children of the parish. There are situations, which arise in families, which make the payment of full tuition impossible. At the same time, the value of a Catholic centered education becomes most obvious. In these instances, which are evaluated on an individual basis, tuition assistance may be offered.

In determining tuition assistance, the recommendation made by **FACTS Grant & Aid**, as well as the number of eligible applicants will be a factor in determining the distribution of the aid. Consequently, every family requesting tuition assistance **MUST complete and submit the FACTS Grant & Aid application each year.** The Pastor, acting on the recommendation of FACTS Grant & Aid, will determine if any tuition assistance will be granted.

If you feel you qualify for assistance, please apply online through the parish website at <https://daytonxii.org/facts-payments-and-grants>, using the FACTS Logo or if you already have an account you may login and apply. Applications must be submitted no later than March 31, 2018. There is a \$28.00 processing fee and applications are due by March 31, 2018. Notification of tuition assistance will be made by early May 2018.
